**Re: Peter Holmes a Court, Wade Singleton, and The Hutch ([www.rabbitohs.com](http://www.rabbitohs.com))**

Your letter of 10 October 2006, which purports to answer my complaint to Peter Holmes a Court about Wade Singleton and The Hutch, advised me to "move on".

Would Peter so easily "move on" if a photograph of his wife was published on a pornographic forum as Wade Singleton did to the spouse of George Piggins? Forum visitors were invited to "take turns, she loves it."

Would Peter be so blasé if I accused him of being a homosexual who went on a "fiddle tour" of the Australian outback? Wade Singleton published similar accusations about Thailand and me - even though I'm not a homosexual and haven't left Australia since 1991.

Likewise, would Peter be so indifferent if someone published an altered photograph showing him performing a sex act on Russell Crowe? This is precisely what Wade Singleton published about Phil Gould and Ricky Stuart.

I also assume from your advice that Peter would be unperturbed if someone accused Russell of drug dealing and having an uncontrollable cocaine habit as Singleton's Hutch alleged of Craig Coleman and Andrew Johns respectively.

Is Peter suggesting that I can somehow ignore the Hutch threat that I "deserve to be set on fire"? Or the warning I received in a 17 seconds tirade from an anonymous caller at 10.18pm on 11 October 2006 that "we will slit your fat fucking throat"?

Does Peter so callously expect Nolene Piggins to expunge from her mind the Hutch's evil suggestion that it would be "wonderful" if she gets "cancer of the larynx" and never spoke again?

Is club legend John Sattler wrong to be angry that the club did nothing to defend him when the Hutch told him to "fuck off" because he is a "busted arse has-been with the IQ of a boiled egg"? Should Gary Stevens have been happy instead of annoyed that he was heckled and abused at the EGM by Peter's Hutch toadies?

The Hutch publishes scandalising lies to incite hatred and violence with the aim of humiliating and intimidating others in the club. I supplied Shane Richardson and Peter with documents proving it. They didn't have the decency to reply. The best they could do was to get an underling to patronise me with gratuitous advice to "move on".

That Peter compromised himself by asking for help from Singleton and his Hutch misfits to win the vote is disgraceful. That Peter's Hutch membership and contribution is ongoing calls into question his primary loyalty to the football club, its members, and legends.

Or is he frightened that they will turn on him with the same viciousness and duplicity they used to defame and threaten a very decent and honest man in George Piggins?

Confidential information is leaked from the football club office to the Hutch. For example, after I complained about The Hutch to Peter and Shane, details were repeated back to me in a menacing group e-mail. And my phone number lost its privacy.

On top of the anonymous call to my cell phone threatening that "we will slit your fat fucking throat", I received a series of menacing text messages aimed at intimidating me from continuing the complaint to Peter.

*"Can't you find something better to do? Point the finger, slow to understand? Arrogance and ignorance go hand in hand."*

*"You bitter old man. How does it feel to be so detested. Isn't life great?"*

*"If you had half a brain you'd know with whom you're speaking. Will you ever learn to accept things that you can't control?"*

*"You are going to be exposed on The Hutch when I could be bothered."*

*"A major embarrassment looms for you soon Milesy. And you won't mind if I publish your mobile number on The Hutch."*

And then I got a letter from you, Leonie, passing on the advice to 'move on' so that Peter can make the club 'great again'. Great? With Peter anchoring it to Wade Singleton and The Hutch?

Has Peter asked Singleton and The Hutch to 'move on' from maligning club members and legends with soul-destroying lies and vicious threats? If so, when and how? If not, Peter should immediately resign as executive chairman.

Please send me copies of the rules canvassing complaint procedures within our great club. We do have rules, don't we?
