I would like to introduce myself to you. My name is Tony Borg and I'm a voting member of the SSDRLFC. I'm writing to advise you of a most unpleasant experience.

At about 12.45pm today Tuesday February 14th I took a phone call from the son of a friend. The callers name was XXXXXXXX XXXXXX. I understand he has some involvement with or is an employee of the South Sydney Club (football or leagues club I'm not sure exactly which). He knows I'm a voting member of the Football Club but didn't know where I stood in relation to the proposal to partially privatise the Football Club.

He advised me that he'd been to a meeting Monday evening (13th February) "with Henry Morris and some solicitors" he said.

He knew that I'd previously worked in the same organisation as Shane Richardson and wanted "some dirt" on him. Shane Richardson was at one point a senior executive with AGC Ltd at that stage a subsidiary of Westpac Bank.

I advised this person there wasn't any dirt and in fact in my opinion he was very highly thought of within the organisation.
